- I. The intake capacity of the students in the first semester is 120.

An applicant who has graduated in any discipline with a minimum aggregate percentage of 45 % (OBC 42 % & ST/ SC 40 %) or has appeared in the final examination of graduation (the result of which is likely to be declared before the selection of candidates) from any of the recognized Indian Universities are eligible for admission provided the candidate must have qualified in RGUCET 2023.
